STATISTICS FOR NOVEMBER 2016: A SUMMARY OF THE LAST MONTH

The library checked out 5375 physical items – books, magazines, DVDs, and other media. A total of 342 e-books were checked out by North Plains card holders. Over all our circulation grew by double digits over November 2015 (+ 13.76%), meanwhile county wide circulation fell by 5%.

There were 4026 people who came into the library during open hours.

The library's public computers were used for 422 hours. An additional 351 hours were logged on the library's wifi system.

There were 36 children and adults who attended Book Babies Storytimes, 95 children and adults who attended Storytimes for preschoolers, and 12 who attended the movie Totero.

There were 8 people in attendance to discuss the Book Club selection, *The Whore's Child* by Richard Russo.

Hours spent in donated time to the library by Friends, Volunteers, and Library Board members totaled 427.

Facebook followers now total 310. There were 198 total Website visits.
